

CLARIFICATION TEXT ON THE PROCESSING OF PERSONAL DATA THROUGH THE WEBSITE ("CLARIFICATION TEXT")

Clarification Text on the Processing of Personal Data through this Website ("Clarification Text") has been prepared to inform and enlighten you about the processes related to the acquisition, storage, transfer to third parties and processing by the company and your rights under the KVKK, Pursuant to Article 10 of the Law on Protection of Personal Data No. 6698 ("KVKK"), and the Communiqué on the Procedures and Principles to be Followed in Fulfilling the Obligation to Clarify, personal data shared by you, our valuable website visitors, with the Company through our website By " Havaalanı İşletme ve Havacılık Endüstrileri A.Ş. " ("Company"), as data controller, residing at Kurtköy, Sabiha Gökçen Airport Pendik Istanbul / TURKEY.

The terms used in this Clarification Text mean the following;

- “personal data”; Any information relating to an identified or identifiable natural person,
- “processing of personal data”; obtaining, recording, storing, preserving, changing, rearranging, disclosing, transferring, taking over, making available, classifying or using personal data in whole or in part by automatic or non-automatic means provided that it is a part of any data recording system. all kinds of operations performed on data such as blocking,
- “data controller”; The natural or legal person (Company), who determines the purposes and means of processing personal data and is responsible for the establishment and management of the data recording system,
- “data processor”; The natural or legal person who processes personal data on behalf of the data controller, based on the authority given by the data controller.

1. Personal Data Processed within the scope of the Clarification Text

Company; It can process some of your personal data through the "www.sgairport.com" website of the Company. In this context, your personal data that can be processed by the Company; your name-surname, phone and e-mail information.

2. For What Purpose Personal Data Can Be Processed and Stored by the Company

Personal data that can be shared by entering information into various forms in certain parts of our company's website at the address "www.sgairport.com"; Information may be processed and stored for the purposes of realizing the benefit you expect, sending your request, suggestion and/or complaint notification through forms such as the "Contact Form", for which you have entered information, and being able to respond to your notification, and to communicate with you on these matters.

3. To Whom Personal Data Can Be Transferred And For What Purpose

Your personal data processed within the framework of this Clarification Text, pursuant to the second paragraph of Article 8 of the KVKK; It can be transferred to third parties if one of the following conditions is met:

- It is clearly stipulated in the laws,
- It is compulsory for the protection of the life or physical integrity of the person or another person, who is unable to express his consent due to actual impossibility or whose consent is not legally

recognized,

- It is necessary to process the personal data of the parties to the contract, provided that it is directly related to the establishment or performance of a contract,
- It is mandatory for the data controller to fulfill its legal obligation,
- The person concerned has been made public by himself,
- Data processing is mandatory for the establishment, exercise or protection of a right,
- Data processing is mandatory for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject.

In the cases listed above, in accordance with the second paragraph of Article 8 of the KVKK; The company may transfer your personal data to third parties without your explicit consent. Except for these cases, the Company; will not transfer your personal data processed within the scope of this Clarification Text to any third party or abroad.

4. Personal Data Collection Method and Legal Reason

Personal data is collected in all kinds of verbal, written or electronic media, within the scope of the above-mentioned purposes, in order for the Company to fully and properly fulfill its contractual and legal obligations.

5. Rights of Personal Data Owner Enumerated in Article 11 of KVKK

In this context, you always have the following rights from the Company's e-mail address kvkk@sgiarport.com;

- To learn whether your personal data is processed,
- If your personal data has been processed, requesting information about it,
- To learn the purpose of processing your personal data and whether they are used in accordance with the purpose,
- To know the third parties to whom your personal data is transferred, in the country or abroad,
- Requesting the correction of your personal data in case of incomplete or incorrect processing and requesting the notification of the transaction made within this scope to the third parties to whom your personal data has been transferred,
- Requesting the deletion or destruction of your personal data in the event that the reasons requiring it to be processed disappear, although it has been processed in accordance with the provisions of the Law No. 6698 and other relevant laws, and to notify the third parties to whom your personal data has been transferred,
- Objecting to the emergence of a result against the person himself by analyzing your processed data exclusively through automated systems,
- To request the compensation of the damage in case of loss due to unlawful processing of your personal data.

Depending on the nature of your request, the company will conclude the request as soon as possible and in any case within 30 (thirty) days at the latest.
